PROFESSIONAL PHOTOGRAPHY POLICY & CONTRACT

We look forward to your visit. We welcome photographers and hope to provide a great location for your year-round and Christmas photos.

Please review and download our contract. If you have any questions, please contact us.

Though we welcome photography year-round at the farm, here are some specific seasons you may be particularly interested in for photos:

- 1. The <u>Sunflower Patch</u> is typically in full bloom beginning around the middle of June and ending around the end of July.
- 2. <u>The Pumpkin Patch</u> season kicks off the last weekend in September and continues all month. There are plenty of photo opportunities such as; a rustic stable, antique farm machinery, pumpkins, corn shocks and straw bales.
- 3. Christmas Tree Season begins whenever you need it for photography sessions.

- Portable bathrooms available during seasonal operations.
- · Ample parking space for you and your clients.
- Green Space for you and your clients to discuss photos.

GUIDELINES AND WHAT TO EXPECT FOR YOUR SESSION

- 1. All professional photography performed at Cross Timbers Christmas Tree Farm must be scheduled and paid for prior to photos being taken. Appointments must be made in advance.
- 2. Cross Timbers Christmas Tree Farm is a fully-operating farmstead. Please take into consideration weather and the natural environment as you and your clients prepare for your visit with us. Boots or closed-toed shoes are recommended. Dress for the weather.
- 3. We ask that children under 12 years of age be accompanied by an adult at all times.
- 4. Please be sure that clients have your contact information. They'll need an easy way to find you. Cross Timbers Christmas Tree Farm Staff is not responsible for directing clients to your photoshoot location.
- 5. Vehicles are not allowed in Christmas tree fields under any circumstances. All props, furniture, etc must be carried to your photoshoot location.
- 6. Any props, clothing, furniture or other objects used for a photo shoot must be removed at the end of the session. A \$25 clean-up fee will be charged if items remain.
- 7. If Cross Timbers Christmas Tree Farm is open to the public, access to certain areas will be restricted. No photo shoots in the tree sale area (the pre-cut tree lot and shop area) during tree sale hours beginning the Friday after Thanksgiving through December 22nd.
- 8. Cross Timbers Christmas Tree Farm reserves the right to prohibit any business disruptions to daily operations or to regular customers due to photography sessions.
- 9. If any fixed or temporary objects are moved or damaged during photography, the photographer will be held responsible for replacement and/or payment.
- 10. Cross Timbers Christmas Tree Farm reserves the right to prohibit inappropriate attire on premises at any time.
- 11. Cross Timbers Christmas Tree Farm prohibits the use of its property by sexually oriented businesses and/or photographers.
- 12. No professional Santa characters may be on site while Cross Timbers Christmas Tree Farm is open to the general public.
- 13. Use care and caution around animals, moving vehicles, and landscaping. This is a farm: watch for snakes, fire ants, wasps, uneven ground, etc. Please heed all safety advisories posted.
- 14. All pets must remain on a leash at all times. Doggie-poo must be removed and disposed of properly. Please bring your own waste bags for doggie clean-up.
- 15. No public area may be closed or blocked to farm customers during regular business hours during your session.
- 16. Every possible effort will be made to accommodate re-scheduling a session due to a weather event. Please contact the farm for any date changes.
- 17. Any activity requiring an outside vendor will require prior notification and approval.
- 18. There may be other professional photographers on the Farm while you are here. Cross Timbers Christmas Tree Farm will reserve settings or specific areas you've selected when scheduling.
